A powerful conversation on visibility, voice and influence

On Friday 9 January, we were delighted to host a highly engaging and thought-provoking webinar with Hayley Mulenda, focused on visibility, influence and personal branding.

The session created a reflective and encouraging space, inviting participants to think more deeply about how they show up, speak up and use their voice with intention and purpose.

Hayley Mulenda is an award-winning speaker, author and entrepreneur, widely recognised for her work on confidence, communication and purposeful leadership. She is the author of *Speak up: how to use your voice to inspire, influence and learn*. Hayley is also a trusted voice in the media and has worked with global brands, leaders and institutions, bringing depth, authenticity and practical wisdom to conversations about identity and influence.

During the webinar, Hayley shared insights drawn from her personal journey and professional experience, challenging the idea that visibility is about self-promotion. Instead, she reframed it as responsibility –

particularly for those whose experiences, skills and stories have the potential to encourage, inform or inspire others. A recurring theme throughout the session was audacity: the courage required to step forward, be seen, and grow into the next level of leadership and impact.

The session also explored personal branding as an expression of integrity rather than image. Hayley encouraged participants to gain clarity around who they are, what they do, why they do it and who their work serves, highlighting the importance of consistency and authenticity over time.

We were especially proud of the way the session was hosted by four of the brilliant young women from our Youth Shadow Board, who facilitated the conversation with warmth, professionalism and confidence. Their leadership helped create a welcoming and supportive



environment that allowed the discussion to flow naturally and meaningfully.

We were pleased to offer a free copy of Hayley's book, *Speak up*, to the first 25 members who registered and attended the full webinar.

Finally, thank you to everyone who attended and supported the webinar. Your engagement made the event impactful. And our sincere thanks to Hayley Mulenda for her generosity, insight and inspiring delivery.

The Black Entrepreneur Report 2026, is a timely, evidence-led update, designed to provide forensic insight into the realities of Black entrepreneurship in the UK.

Your input will help strengthen the evidence base used by policymakers, funders and institutions.

High-quality data helps to:

- influence policymakers with evidence (not assumptions)

- unlock long-term social, economic and political impact.

The survey takes less than 10 minutes, but the collective impact could be substantial. Findings will be shared widely across government, industry, finance, and the investment community, helping ensure Black entrepreneurial voices are heard and acted upon.

Justice for the Windrush Generation:

How Ultra Education CIC is supporting your claim

The Windrush scandal remains one of the most significant injustices in recent British history.

For decades, members of the Windrush generation – individuals who arrived in the UK from Commonwealth countries between 1948 and 1973 – built lives, families and careers, only to be wrongly categorised as ‘illegal migrants’. The resulting impact was devastating, leading to lost jobs and homes, and withdrawn access to essential services like healthcare.

In response, the UK government established the Windrush Compensation Scheme (WCS). However, navigating the legal complexities, and gathering the required decades-old evidence, can be an overwhelming task. This is where Ultra Education CIC steps in.

Providing a bridge to justice

Ultra Education CIC is proud to be a recipient of the Windrush Compensation Advocacy Support Fund (WCASF). Our mission is to ensure that no-one is left behind due to ‘onerous bureaucracy’.

We provide a trusted, culturally sensitive environment where potential claimants can feel safe sharing their stories and pursuing the compensation they are rightfully owed.

We understand that for many, the trauma of the past makes it difficult to engage with official systems. Our advocates act as your personal partners throughout the journey, offering free and confidential support tailored to your unique circumstances.



Support in north and south London

To ensure our services are at the heart of the community, Ultra Education has deployed dedicated advocates across north and south London. Whether you are a primary claimant, a family member who has suffered a loss, or representing the estate of a loved one, our team is positioned to help you.

Our support includes the following.

- **Articulating your story:** helping you to document the full impact the scandal had on your life, so your claim is comprehensive.
- **Evidence gathering:** assisting in the difficult task of locating records, such as school reports, employment history, and old travel documents.
- **Application guidance:** walking you through the forms to minimise stress and maximise the chance of a successful outcome.

Community clinics

Information is power. Ultra Education hosts regular advocacy clinics and information events to demystify the process. Our weekly advocacy clinics

take place on Wednesdays (11am to 1pm) and Thursdays (7-9pm) at The Lewinson Centre, 167 High Road, London NW10 2SG.

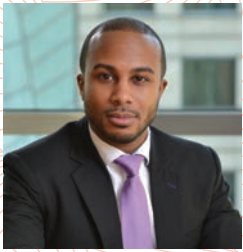

These clinics offer a space for one-on-one consultations. We also run ‘Pop-up Hubs’ and community information sessions, where you can learn about eligibility criteria – such as arrival dates before 1973 (Commonwealth) or 1988 (any country) – and the various categories of claimable loss, including housing, health and employment.

Take the first step

If you or someone you know has been affected by the Windrush scandal, you do not have to face the application process alone. Our advocates are here to provide the empathy and expertise needed to secure justice.

New year, same goals... But are you actually moving towards them?

A new year often brings renewed focus but, for many, 2026 is less about setting new goals and more about examining whether existing plans are being followed with intention. Wealth may provide flexibility, yet long-term success still depends on structure, discipline and regular review.

Recent insights from the Moneybox Financial Confidence Index 2025 highlight how financial engagement is shifting across the UK. Among those who described themselves as financially confident, 48% followed a budget, up from 33% the previous year, and 49% set long-term financial goals, compared with 34% in 2024.

Confidence in investing also increased, rising from 33% to 39%. These trends don't suggest a single 'right' approach, but they do indicate that many individuals are becoming more intentional about how they manage their finances.

The start of 2026 offers an opportunity to pause and reassess. Are you actively implementing your financial plan, or relying on assumptions made years ago? Are your spending patterns aligned with your long-term objectives? Are you regularly reviewing your financial plan to ensure it still supports the future you envision?

This year doesn't demand new goals; it calls for a refreshed
